

Tender Notice (TN) / Invitation for Bids (IFB)

Title of Tender: **Purchase of LTM for Competence based curriculum 2015-2016**

The RWANDA EDUCATION BOARD (hereinafter called “the Client”) will receive funds from the Government of the Republic of Rwanda and from different donors towards the costs of procuring **LTM for competence based curriculum 2015-2016**. The Client intends to apply a portion of the funds to eligible payments under the contract for which this Bidding Document is issued.

1. The Rwanda Education Board invites qualified bidders to **submit textbook, teachers’ guide and Kinyarwanda reading book proposals in line with current curriculum and syllabus specifications for evaluation and potential inclusion on a national Approved List of Learning and Teaching Materials, from which Rwanda Education Board will select the learning and teaching materials for each school up to the limits of annual individual school learning and teaching materials budgets based on nationally approved per capita financial allocations. REB will provide the list of schools to which delivery must be made. Details of the learning and teaching materials for which submissions are required are provided in detail in the Statement of Requirements.**
2. Tender Documents in the English Language may be obtained from the Rwanda Education Board, Stadium Road, REMERA, PO BOX 3817, Kigali upon presentation of proof of payment of a non-refundable fee of Fifteen thousand Rwanda Francs (15 000 RWF) to Account N° 120-00-46 RA opened at The National Bank of Rwanda (BNR) or at any branch of RRA .
3. Tender Documents may be obtained on any working day from the office of Procurement (REB) between 09:00 am and 16:00 Pm.
4. All bids shall be accompanied by a Bid Security of \$ 1000 for lot 1,2 and 3 each, \$ 5000 for lot 4,5and 6each, and/or a non-refundable Bid Submission Fee in local currency or in a freely convertible currency.
5. Enquiries regarding this tender may be addressed to Rwanda Education Board (REB), Stadium Road, REMERA, and P.O.BOX 3817 KIGALI.

6. Well printed bids, properly bound and presented in four copies one of which is the original must reach the REB-Procurement Office at the address mentioned above not later than 30/09/2015 at 09:00 local time or 07.00 GMT. Late bids will be rejected.
7. Technical samples comprising dummies bound as specified, text paper and cover card samples should be submitted in one copy
8. Page proofs and complete manuscripts for content evaluation should be submitted in 6 copies and should contain no information which should enable the samples to be identified as originating from any publisher or author or group of authors. Thus, the page proofs and manuscripts should be submitted without covers and prelims and should contain no publishers' name or logo or the names of authors, illustrators, designers, advisors or consultants. Failure to provide page proofs and samples, which will be anonymous to the evaluation panels, could lead to the disqualification of the bid submission. The REB will be responsible for devising a coding system to prevent the identification of page proofs and manuscripts by any evaluator
9. Bids will be opened in the presence of bidders or their representatives who choose to attend at REB BOAD ROOM Head quarter on 30/09/2015 at 10 00 hours local time or 08 00 GMT
